
The Licking Land Trust continued in excellent financial health in fiscal year **1** 2019. Farm-to-Fork, the Trust's annual fundraiser, saw its highest-ever net proceeds, and the organization remained debt-free.

During 2019, total revenues of \$58,778 were received by the Trust. Of that amount, membership dues comprised 37.7% (\$22,132). The second-largest source of income was the Trust's fundraiser, Farm-to-Fork, raising gross receipts of \$19,591 (33.3% of total Trust revenues). Investment earnings brought in \$14,600 (24.5% of total), and other operating donations of \$2,455 comprised 4.2%.

Expenses for the year, totaling \$37,870, are exhibited in the sections of the pie chart, which each include staff time: (1) Programs, including conservation, education, and engagement with other environmental organizations, comprised 23% (\$8,599) of total expense. Costs of the organization's program initiatives, such as stewardship and educational activities, are substantially defrayed by volunteer efforts of the 2019 Expenses: \$37,870 Board, members, and supporters. (2) Office and administrative costs, which are largely fixed costs, represent 52% Land Programs (\$19,619) of expense. (3) Membership Office & communications and development, Administrative the majority of which is staff time, Membership were \$14% (\$5,316). (4 & 5) Finally, investment management (\$997) slightly Investment exceeded 2.5% of total expense, and the Management 52% cost of hosting the Farm-to-Fork event Farm-to-Fork Fundraiser was slightly under 9% (\$3,339).

The financial statements of the Licking Land Trust are compiled on a monthly basis and reviewed by the Board's Finance Committee as well as by the full Board. Dues and donations, operating funds, investment accounts, and all expenses are reviewed, as are the operating budget categories and their status, year-to-date, versus actual. The Finance Committee provides guidance to the Treasurer and recommendations to the Board concerning operating budget, investments, and other financial matters.
